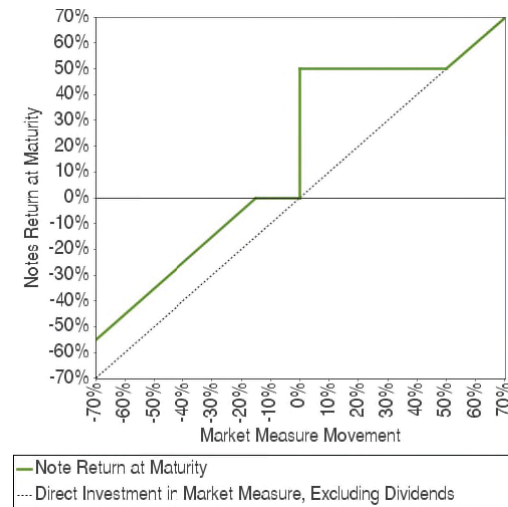

	Autocallable Market-Linked Step Up Notes Linked to the EURO STOXX 50® Index
Issuer	HSBC USA Inc. ("HSBC")
Principal Amount	\$10.00 per unit
Term	Approximately five years, if not called
Market Measure	The EURO STOXX 50® Index (Bloomberg symbol: "SX5E")
Automatic Call	The notes will be called automatically on any Observation Date if the closing level of the Market Measure is equal to or greater than the Call Level
Call Level	100% of the Starting Value
Observation Dates	Approximately one year, two years, three years and four years from the pricing date
Call Amounts	[\$10.95 to \$11.05] if called on the first Observation Date, [\$11.90 to \$12.10] if called on the second Observation Date, [\$12.85 to \$13.15] if called on the third Observation Date and [\$13.80 to \$14.20] if called on the final Observation Date, each to be determined on the pricing date

Step Up Payment	\$5.00 per unit, a 50% return over the principal amount
