Funds From Operations, page 67

1. We note that in your reconciliation of Funds From Operations you appear to make a negative adjustment to net earnings to add back a loss from sales of undepreciated property. Please clarify whether this is actually a loss or a gain, how this amount was derived, and where the resulting gain or loss appears on the income statement and statement of cash flows.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes the information the Securities Exchange Act of 1934 and all applicable Exchange Act rules require. in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.

In responding to our comments, please provide a written statement from the company acknowledging that:

- staff comments or changes to disclosure in response to staff comments do not foreclose the Commission from taking any action with respect to the filing; and
- the company may not assert staff comments as a defense in any proceeding initiated by the Commission or any person under the federal securities laws of the United States.
