CORRECTION - GOLDCORP INCREASES DIVIDEND

VANCOUVER, BRITISH COLUMBIA, March 7, 2011 – GOLDCORP INC. (TSX: G, NYSE: GG). In the press release issued on February 24, 2011 it was noted the annual dividend was increased to \$0.40 per common share (\$0.0333 per common share on a monthly basis) this should have been \$0.408 per common share (\$0.034 per common share on a monthly basis).

Goldcorp announced on February 24, 2011 that its Board of Directors has authorized an 11% increase in the annual dividend to \$0.408 per common share. This follows a doubling of the dividend in October 2010. A dividend of \$0.034 per common share per month will be payable to shareholders of record as of March 17, 2011. Goldcorp is the only gold producer to pay a monthly dividend. The increase is being driven by increasing cash flows due to growing gold production and a continued strong metals market.

Goldcorp is one of the world's fastest growing senior gold producers. Its low-cost gold production is located in safe jurisdictions in the Americas and remains 100% unhedged.
