

**GOLDCORP ELECTS CLEM PELLETIER TO BOARD OF DIRECTORS;  
ANNOUNCES VOTING RESULTS FROM ANNUAL SHAREHOLDERS MEETING**

**Vancouver, British Columbia, May 2, 2014 – GOLDCORP INC. (TSX: G, NYSE: GG) (“Goldcorp” or the “Company”)** is pleased to announce the election of Mr. Clement A. Pelletier to its Board of Directors. Mr. Pelletier, 68, currently serves as Chief Executive Officer of Rescan Group Ltd., a Canada-based environmental consulting firm to the resource industry. The Company also announced that A. Dan Rovig has retired from the Goldcorp Board of Directors, leaving the number of directors at ten.

“Clem Pelletier is a resource industry veteran, having served as both a mine operator and the founder of an important engineering and environmental firm over the course of an impressive career,” said Ian Telfer, Chairman of the Board of Goldcorp. “He has received numerous awards and recognition for industry accomplishments, particularly in the area of environmental performance, and will be an important addition to the Goldcorp team. On behalf of the board and management team, we would like to thank Dan Rovig for his contributions and leadership. Since 2006, he has served Goldcorp’s board with the utmost integrity and distinction.”

The Company also announced the detailed voting results for the election of its Board of Directors, which took place at the Company’s Annual and Special Meeting held on May 1, 2014. The nominees listed in the management proxy circular dated March 18, 2014 were elected as directors of Goldcorp at the meeting. Detailed results of the vote are set out below:
