Prime Dealer Services Corp. (the "Company") is a registered broker-dealer subject to Rule 17a-5 promulgated by the Securities and Exchange Commission (17 C.F.R. § 240.17a-5, "Reports to be made by certain brokers and dealers"). This Exemption Report was prepared as required by 17 C.F.R. § 240.17a-5(d)(1) and (4). To the best of its knowledge and belief, the Company states the following:

- (1) The Company does not claim an exemption under paragraph (k) of 17 C.F.R. § 240.15c3-3, in reliance on footnote 78 of Release 34-70073 regarding adopting amendments to 17 C.F.R. § 240.17a-5; and
- (2) The Company is filing this Exemption Report relying on footnote 78 of the SEC Release No. 34-70073 adopting amendments to 17 C.F.R. § 240.17a-5 because the Company's sole business activity is securities lending (stock loan/borrow) transactions with counterparties. All transactions are conducted pursuant to Master Securities Loan Agreements, with all loans fully collateralized. The Company does not hold customer accounts or proprietary accounts of broker dealers as defined in 17 C.F.R. § 240.15c3-3, and thus did not directly or indirectly receive, hold, custody or otherwise owe funds or securities for or to customers (collectively the "identified circumstance").

The Company met the identified circumstances throughout the year ended 12/31/2021 without exception.
