Item 4.01 Changes in Registrant's Certifying Accountant

1. We note that you consulted with Cherry, Bekaert & Holland (CBH), your successor auditors, in March 2012 regarding a specific revenue transaction. We further note that CBH did not indicate or provide their professional opinion with respect to the appropriate revenue recognition for the transaction. Please confirm whether the conclusions reached by the company, CBH and Marcum, your predecessor auditor, were consistent.
2. Additionally, please describe your consideration of the requirements in Item 304(a)(2)(ii)(D) of Regulation S-K and amend your filing accordingly.
3. In your amended Form 8-K, include an Exhibit 16 letter from the former accountant referencing the revised Form 8-K.

- the company may not assert staff comments as a defense in any proceeding initiated by the Commission or any person under the federal securities laws of the United States.

In addition, please be advised that the Division of Enforcement has access to all information you provide to the staff of the Division of Corporation Finance in our review of your filing or in response to our comments on your filing.
