### Investment Description

- Linked to the S&P 500® Index due February 5, 2024
- Unlike ordinary debt securities, the Securities do not pay interest or repay a fixed amount of principal at maturity. Instead, the Securities provide for a Payment at Maturity that may be greater than, equal to or less than the Principal Amount of the Securities, depending on the performance of the Reference Asset from the Initial Level to the Final Level.

The Payment at Maturity will reflect the following terms:

o **If the level of the Reference Asset increases:**

You will receive the Principal Amount plus 127% participation in the upside performance of the Reference Asset

o **If the level of the Reference Asset is flat or decreases but the decrease is not more than 30%:**

You will be repaid the Principal Amount

o **If the level of the Reference Asset decreases by more than 30%:**

You will have full downside exposure to the decrease in the level of the Reference Asset from the Starting Level, and you will lose more than 30%, and possibly all, of the Principal Amount.

- Investors may lose a substantial portion, or all, of the Principal Amount
- Any payments on the Securities are subject to TD's credit risk

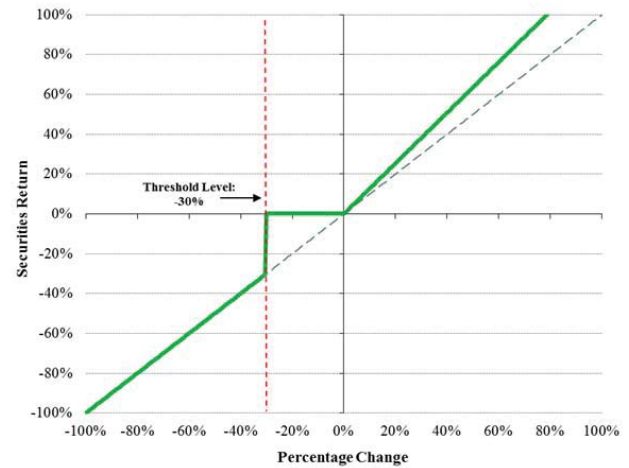

## Hypothetical Payout Profile

The profile to the right is based on the Leverage Factor of 127%, and a Threshold Level equal to 70% of the Initial Level.

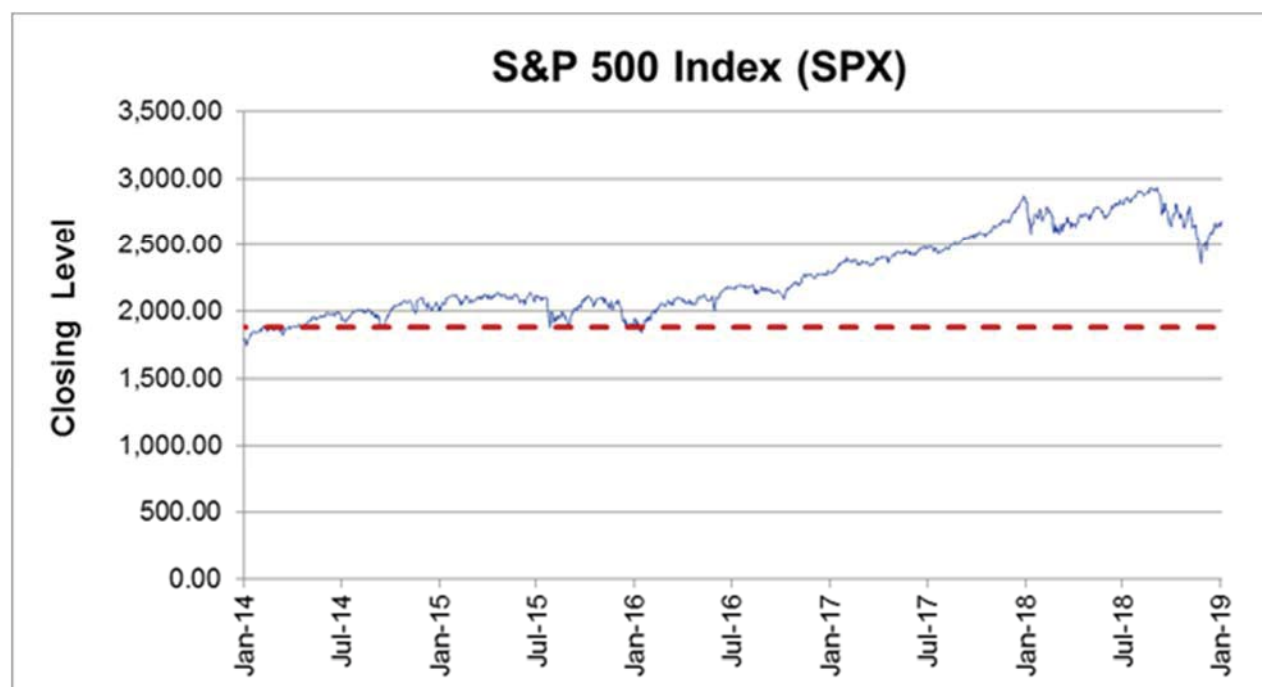
## How the Payment at Maturity is Calculated

The Payment at Maturity will be determined as follows:

- If the Percentage Change is positive, then an investor will receive an amount per Security equal to:  
$$\text{Principal Amount} + (\text{Principal Amount} \times \text{Percentage Change} \times \text{Leverage Factor}).$$
- If the Final Level is equal to or **less than the Initial Level, but greater than or equal to the Threshold Level (the Percentage Change is 0% or negative but not below -30%)**, then an investor will receive an amount per Security equal to:  
$$\text{Principal Amount}.$$
- If the Final Level is less than the Threshold Level (the Percentage Change is **negative and below -30%**), then the investor will receive less than the Principal Amount, if anything, per Security, calculated using the following formula:  
$$\text{Principal Amount} + (\text{Principal Amount} \times \text{Percentage Change}).$$

If the Final Level is less than the Threshold Level, the investor will have full exposure to the decrease in the level of the Reference Asset and will lose more than 30%, and possibly all, of the Principal Amount. Specifically, investors will lose 1% of the Principal Amount for each 1% decrease from the Initial Level to the Final Level and may lose all of the Principal Amount.

## Historical Performance of the Reference Asset



\* The graph above sets forth the historical daily performance of the Reference Asset from January 30, 2014 through January 30, 2019. The graph is based upon actual daily historical closing levels of the Reference Asset. The dotted line represents the Threshold Level of 1,876.735, which is equal to 70% of the Closing Level of the Reference Asset on January 30, 2019.
