



Subject: : JSC "Khanty-mansiyskokrtelecom" has stopped its participation in the authorized capital JSC "Ural GSM" on 25<sup>th</sup> of DECEMBER 2001.

Text of the message:

JSC "Ural GSM" was found in 1998, principal activity of the company - granting cellural radio-telephone communication services within the range of 1800 MHZ, beginning from November 1998 JSC "Khanty-mansiyskokrtelecom" was the owner of 7,21% from the authorized capital of companies.

During 2001 year the authorized capital JSC "Ural GSM" increased by way of additional share production and its accomodation by the private subscription from 969.210 rub. up to 6.165.000 rub., under the unchangeable contribution amount of JSC "Khanty-mansiyskokrtelecom" to the authorized capital JSC "Ural GSM" its share in the authorized capital of companies reduced from 7,21% to 1,13%.

The share block of JSC "Ural GSM" which is in possession of JSC "Khanty-mansiyskokrtelecom" is sold by the decision of SLL "Telecominvest" Directors Board on the following conditions :

- Share amount - 776 pieces.
- One share cost - 700 roubles.
- Sare block overall cost- 543200 roubles.
