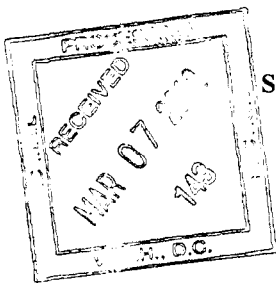

C.5. Offering Price, Number of Investors, Expenses and Use of Proceeds (con't)

Note to C.5.: The adjusted gross proceeds to the issuer of the Common Stock listed in Item C. 4.b. is identical to the aggregate offering price of the Common Stock listed in Item C.1. because none of the expenses listed in Item C.4.a. have been deducted from the aggregate offering price. No deduction for such expenses was made because the shares of Common Stock have been issued in the name of an escrow agent (with beneficial ownership by the shareholders of CoolTouch Corporation, a California corporation ("CoolTouch")) pending further adjustment in the number of such shares and the release of the shares to the CoolTouch shareholders, pursuant to that certain Agreement and Plan of Reorganization dated January 18, 2002 between ICN and CoolTouch, and that certain Escrow Agreement dated February 4, 2002, between ICN, CoolTouch, Roth Capital Partners, LLC (a California limited liability company), as representative of the CoolTouch shareholders, and American Stock Transfer & Trust Company, a New York corporation, as escrow agent. Because the Common Stock was issued in exchange for assets, we believe that it would be inappropriate to deduct such amounts.
