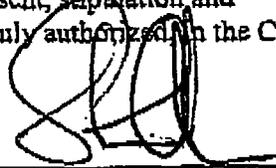

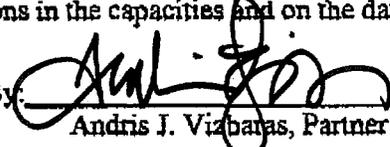

Instructions
