Brief Description of Business

Preferred Term Securities V, Ltd., a Cayman Islands exempted limited liability company (the "Issuer"), and Preferred Term Securities V, Inc., a Delaware corporation (the "Co-Issuer" and, together with the Issuer, the "Co-Issuers"), propose to offer for sale up to U.S. \$312,400,000 aggregate principal amount of Floating Rate Senior Notes Due April 3, 2032 (the "Senior Notes") and U.S. \$201,450,000 aggregate principal amount of Floating Rate Mezzanine Notes Due April 23, 2032 (the "Mezzanine Notes") and the Issuer alone proposes to offer for sale up to U.S. \$49,850,000 aggregate principal amount of Subordinate Income Notes Due April 3, 2032 (the "Income Notes" and, together with the Senior Notes and the Mezzanine Notes, the "Notes"). The Issuer will own various preferred trust securities, two capital securities which will be acquired in the secondary market and a bank's subordinated debenture.

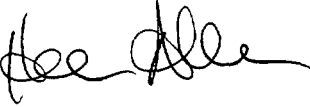
