

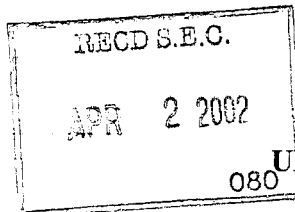

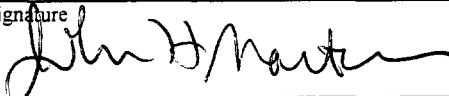

Note 1: A management fee (the "Management Fee") will be paid quarterly by the Issuer to Alva Management Corp. at an annual rate equal to the applicable percentage of the excess of (i) all Subscriptions of all Partners over (ii) the amount committed by the Partnership to its subsidiary partnership, Edison Fund V, L.P. The applicable percentages are as follows: (1) 1.80% for the twelve month period beginning on the initial closing date; (2) 2.15% for the twelve month period beginning on the first anniversary of the initial closing date through the second anniversary of the initial closing date; (3) 2.50% for each of the twelve month periods beginning on the second anniversary of the initial closing date through the seventh anniversary of the initial closing date; (4) 2.10% for the twelve month period beginning on the eighth anniversary of the initial closing date and (5) 1.60% beginning on the ninth anniversary of the initial closing date and thereafter. However, in no event shall the Management Fee be in an amount less than \$125,000 for any three-month period. The amount of the Management Fee will be reduced by the aggregate amount of director's fees, consulting fees and other cash or non-cash remuneration, if any, received from or in connection with portfolio companies or prospective portfolio companies of the Issuer.

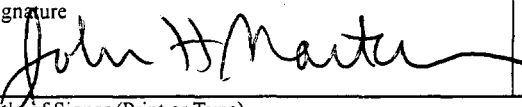
