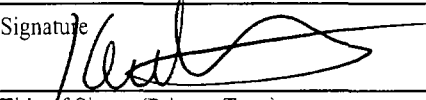

- B.4. While the issuer is authorized to sell limited partnership interests through third parties and pay commissions, it has not yet elected to retain anyone for that purpose. Additionally, the general partner of the issuer may award increased compensation to any of its members that are responsible for helping to raise capital for the issuer. Compensation will be in the form of increased interests in the general partner, which indirectly results in increased limited partnership interests in the issuer. Certain of the members of the general partner are principals or employees of, or otherwise associated with, Commonwealth Associates, L.P., a registered broker dealer. However, at this time, it is not possible to set forth the members of the general partner that will receive such compensation.
