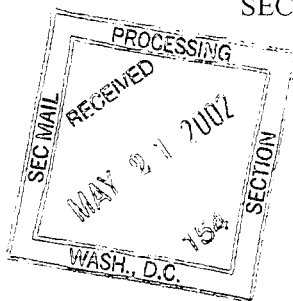

Rider to Form D

Each purchaser of Special Warrants of Qbiogene Inc. in the Canadian Provinces indicated will be deemed to have represented to the Company and to the Agent, that such purchaser (the “purchaser”):
