### **2001 FINAL DIVIDEND PAYMENT**

**New York, June 18th 2002.** The Shareholders' General Meeting of Endesa, S.A. (NYSE: ELE) of May 10<sup>th</sup>, 2002 approved a 2001 total dividend of Euro 0.6825 per share.

Since on January 2<sup>nd</sup>, 2002 an interim gross dividend of Euro 0.264 per share was paid against year 2001 results, a final gross dividend of Euro 0.4185 per share will be paid on July 1<sup>st</sup>, 2002, less applicable withholding taxes.

Payment of the above amount will be made through Santander Central Hispano Investment, S.A., to the entities belonging to the Servicio de Compensación y Liquidación de Valores (S.C.L.V.) in which the shareholders hold their shares in deposit, upon submission of the corresponding documentation that attests on their share ownership.
