Brief Description of Business Aros Corporation has been involved in the healthcare industry for over 15 years. Aros was formed as APACHE Medical Systems in 1987 and it was a provider of clinically based decisions support information systems, clinical data base management services, and clinical trial consulting services until July 2001, when it sold substantially all of its assets to Cerner Corporation in a cash transaction. Aros acquired ReGen Biologic Inc. in June 2002. ReGen is a tissue regeneration company that designs, develops, manufactures and markets minimally invasive implants and medical devices for the repair and regeneration of damaged tissue with a current focus on orthopedics. Aros common stock is traded on the OTC bulletin board.

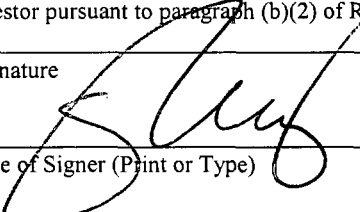
