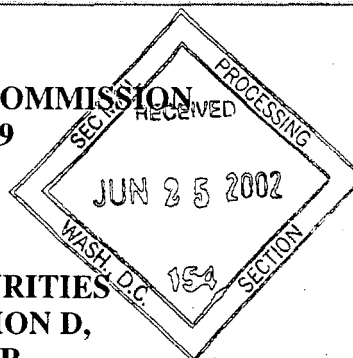

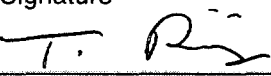

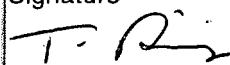

EXHIBIT "A"

The minimum cash investment accepted from any individual will be \$10.00 (one membership unit). In addition to the \$10.00 in cash, each investor must: (1) deliver an Irrevocable Standby Letter of Credit in an amount equal to \$15,000.00 per membership unit acquired to secure the Company's Line of Credit (which is not expected to exceed \$300,000.00); and (2) contribute additional capital to the Company in an amount of \$2,500.00 per membership unit acquired, which will be deducted and held by the Company from the first cash distribution(s), if any, from the Company to the Members.

Therefore, the actual cash proceeds that will be paid to the Company from the sale of the membership units will be \$10.00 per unit with a maximum of \$200.00 (a maximum of 20 membership units are being sold). The balance of the money will come from the Company's Line of Credit – which will be secured by the Irrevocable Standby Letters of Credit – and the additional capital contributions withheld from the cash distributions from the Company, if any.
