



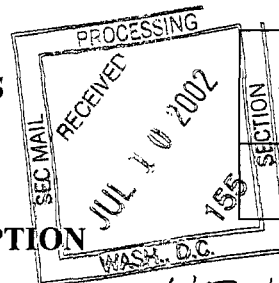

<sup>2</sup> The securities being offered are intended to be exempt from the registration requirements of the Securities Act of 1933 pursuant to Rule 506 of Regulation D promulgated thereunder. Each of the 8 investors purchasing membership interest units in this offering is an accredited investor. Five such investors reside in the U.S. Three such investors were incorporated under the laws of Guernsey, the U.S. Virgin Islands and the British Virgin Islands. Accordingly, the aggregate number of investors residing in the U.S. is 5 and the aggregate dollar amount of their purchases is \$1,045,843.68. 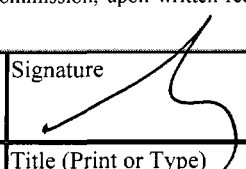

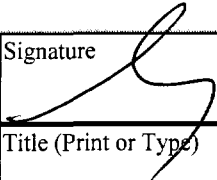
