

TELKOM COMPLETES SALE OF 12.7% INTEREST IN PT TELEKOMUNIKASI SELULAR

Bandung, July 30, 2002, It is hereby announced that today on July 30,2002, PT Telekomunikasi Indonesia, Tbk completed the sale of the Company's 12.7% stake in PT Telekomunikasi Selular ("Telkomsel") to Singapore Telecom Mobile Pte Ltd ("SingTel Mobile"), a wholly-owned subsidiary of Singapore Telecommunications Limited ("SingTel").

As result this transaction, TELKOM maintained 65% ownership in TELKOMSEL, while SingTel Mobile increased its ownership up to 35%. TELKOM received a full cash consideration of US\$429 million.


