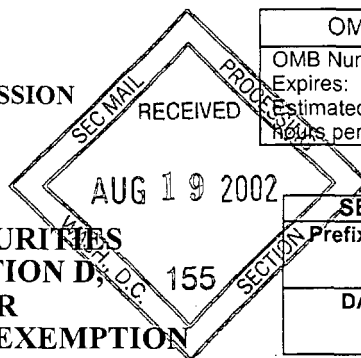

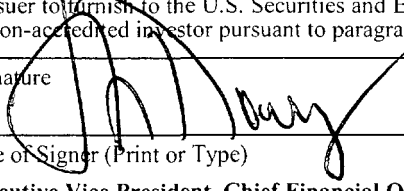

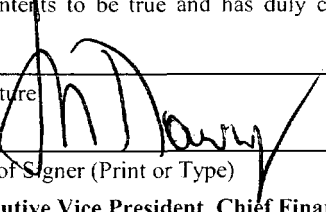

APPENDIX A

- Note to B.4.:** UCBH believes that MPAC has solicited only Purchasers who are accredited investors and/or are located outside of the U.S.
- Note to C.1.:** Each Purchaser has paid or will pay the offering price for the shares of UCBH Common Stock in shares of the Common Stock of Bank of Canton of California, a California banking corporation ("BCC").
- Note to C.2.:** UCBH believes that all Purchasers are accredited investors and/or are located outside of the U.S. The \$51,250,000 "Aggregate Dollar Amount of Purchases" represents the entire offering.
- Note to C.4.a.:** MPAC will receive a fee of 10% of the "Aggregate Offering Price" in the event that UCBH is able to acquire all or substantially all of the outstanding shares of BCC.
- Note to C.5.:** The adjusted gross proceeds to UCBH of the Common Stock listed in Item C.4.b. is identical to the "Aggregate Offering Price" of the Common Stock listed in Item C.1. because none of the expenses listed in Item C.4.a. have been deducted from the "Aggregate Offering Price." No deduction for such expenses was made because the shares of Common Stock of UCBH have been issued to certain shareholders of BCC, pursuant to separate definitive stock purchase agreements received from such shareholders. Because the Common Stock was issued as consideration for BCC shares sold by such shareholders, we believe that it would be inappropriate to deduct such amounts.
