

Footnote to Part C - Question 5

Salaries and Fees

Issuer will pay its investment manager, a quarterly advisory fee which will vary depending upon Issuer's performance relative to a predetermined "Quarterly Base Return." If Issuer's actual return is equal to or less than the Quarterly Base Return, the advisory fee for the applicable quarter is equal to one quarter of 0.50% of the net asset value of Issuer. If Issuer's actual return is greater than the Quarterly Base Return, the advisory fee for the applicable quarter will be increased by 20% of the excess, but in no event greater than a total of one quarter of 2.50%.
