



- (1) In connection with this offering, shares of Series B Convertible Preferred Stock have been issued upon conversion of the outstanding principal and accrued interest under the Convertible Notes of Psychiatric Genomics, Inc. The offer and sale of these Notes occurred between August 31, 2001 and November 7, 2001. The aggregate principal amount of the Notes was \$10,025,000, of which Notes in the aggregate principal amount of \$5,745,000 were offered and sold to investors that are residents of the United States, as described in the Form D filed with the SEC by Psychiatric Genomics, Inc. on September 15, 2001. The total accrued interest on the Notes as of the conversion date was \$699,917.69, of which \$511,460.19 has been included in this filing. The remainder of the interest has not been converted.
