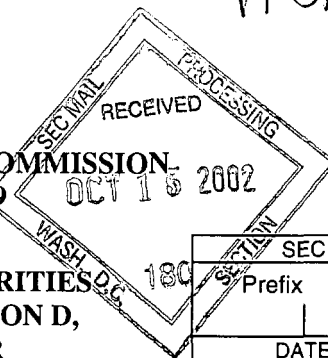

(the "Company") authorized the sale of 67,188,285 Class E Convertible Preferred Units (the "Class E Units") for an aggregate offering price of \$5,375,063.05 in two tranches, the first of which was funded immediately and the second of which was funded on October 9, 2002. On October 10, 2002, the Company sold an additional 6,250,000 Class E Units to a co-investor for an aggregate offering price of \$500,000. The information set forth below reflects the funding of the second tranche financing, under which 16,377,339 Class E Units were sold for \$1,310,187, and the sale of the 6,250,000 additional Class E Units on October 10, 2002.

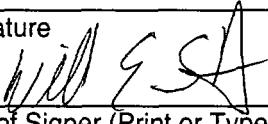
