



Avasta, Inc. ("Avasta") issued an aggregate of 23,562,180 shares of Series C Preferred Stock, par value \$.01 per share, to certain shareholders of siteRock Corporation, a California corporation ("siteRock"), upon consummation of the merger of SR Acquisition Corp., a wholly-owned subsidiary of Avasta ("Acquisition Sub") with and into siteRock pursuant to an Agreement and Plan of Merger and Reorganization among Avasta, siteRock, Acquisition Sub and certain shareholders of siteRock (the "Merger").

The Merger was consummated on July 26, 2002 (the "Effective Date"). In connection with the Merger, (a) Acquisition Sub was merged with and into siteRock, (b) each share of common stock and preferred stock of siteRock, other than shares of Series E Preferred Stock of siteRock (the "Series E Preferred Stock") was cancelled (c) each share of Series E Preferred Stock was converted into the right to receive an exchange ratio of a share of Series C Preferred Stock of Avasta and (d) each share of common stock of Acquisition Sub was converted into one share of common stock of siteRock.
