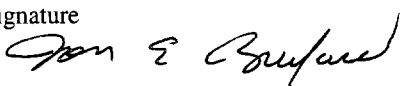

ANNEX I
Bartech Technical Services LLC, Form D
Notice of Sale of Securities Pursuant To Regulation D

In connection with the acquisition by Bartech Technical Services LLC, a Michigan limited liability company, and certain of its affiliates (collectively "Bartech") of substantially all of the assets of Rapid Design Service, Inc., a Michigan corporation, and certain of its affiliates and subsidiaries (collectively "RDS"), Bartech conveyed to RDS the following which may be securities under both federal and state laws:

1. A Contingent Promissory Note in a face amount up to Four Million Dollars. The actual amount of principal due and payable pursuant to this instrument will not be determined until January 31, 2003. The calculation of the principal amount of the Note is a formula whereby the labor gross margin for the period from September 1, 2002 and January 31, 2002, after certain agreed to additions and subtractions, is subtracted from certain threshold numbers. If the resulting number is a negative at a given threshold, then that amount is added to the principal on the note and each such amount is added together to arrive at the final principal amount of the Note.

2. An Earnout Agreement pursuant to which Bartech may be required to make payment to RDS on each of September 13, 2003 and September 13, 2004. The calculation of amount of the Earnout for a given year is a formula whereby the labor gross margin attributable to specified customers of Bartech and prior customers of RDS for the period, after certain agreed to additions and subtractions, is subtracted from certain threshold numbers. If the resulting number is a negative for the period, then that amount is due and payable to RDS for that period. Bartech currently estimates that there will be no payment on September 13, 2003 and that the maximum possible payment on September 13, 2004 is less than One Million Dollars.
