Form D – Odyssey Resources Limited

A total of 2,477,168 Units were sold under the issuer's private placement at a price of Cdn.\$0.30 per Unit, of which 400,000 Units were sold into the United States for proceeds of Cdn.\$120,000 (approximately US\$76,311.61).

Each Unit consists of one common share and one non-transferable common share purchase warrant ("Warrant") of the issuer. Each Warrant is exercisable at a price of Cdn.\$0.35 until October 17, 2003 and thereafter at a price of Cdn.\$0.45 until October 17, 2004.

The Offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
