





Creo Inc. ("Creo") issued \$4,000,000.16 in Convertible Promissory Notes, to the shareholders of Scenicsoft, Inc., a Washington corporation ("Scenicsoft"), upon consummation of the merger of Creo Acquisition, Inc. a Washington corporation and a wholly owned subsidiary of Creo ("Merger Sub") with and into Scenicsoft pursuant to an Agreement and Plan of Merger among Creo, Merger Sub and Scenicsoft (the "Merger").

The Merger was consummated on October 24, 2002. Pursuant to the Merger, (a) Merger Sub merged with and into Scenicsoft and Scenicsoft became the surviving corporation under the name "Scenicsoft, Inc.", and (b) Scenicsoft shareholders received \$9.00 per share of Creo Inc. in exchange for each share of their Scenicsoft stock. The aggregate offering price shown in response to Item C.1 represents Promissory Notes issued to shareholders of Scenicsoft in exchange for their Scenicsoft stock, based on a price of \$9.00 per share of Creo Stock.
