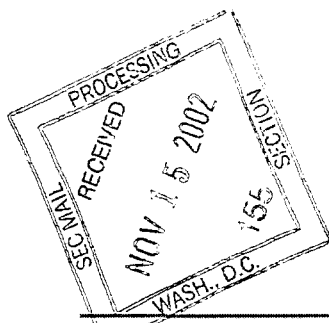

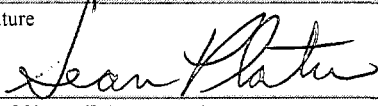

Item 5: Salaries and Fees

The Fund's Investment Adviser receives an annual Management Fee payable quarterly of $1\frac{3}{4}\%$ per annum of the Net Asset Value of the Fund. The Investment Adviser is also entitled to a Performance Fee, payable annually, equal to 15% of the cumulative net appreciation, if any, in the Net Asset Value of the Common Shares, but only in the event the Fund's Net Asset Value increases each year by at least 5% after taking into account the annual Management Fee.
