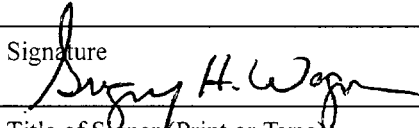

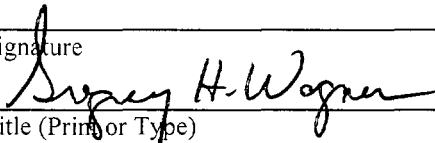

Schedule A

Transaction

On or about August 25, 2000, the Issuer issued to Chabra an aggregate of Twelve Million (12,000,000) shares of Series B Preferred Stock, par value \$.001 per share, of the Company (the "Series B Preferred Stock"), with a stated value of One Dollar Twenty-Five Cents (\$1.25) per share, representing an aggregate of Fifteen Million Dollars (\$15,000,000) worth of Series B Preferred Stock. Since the date of issuance of such shares, and through the accrual of dividends on such shares, Chabra has earned accrued dividends in the aggregate amount of Three Million Three Hundred Sixty-Six Thousand Six Hundred Sixty-Seven (\$3,366,667), which dividends the Issuer elected to pay fully with the issuance of Two Million Six Hundred Ninety-Three Thousand Three Hundred Thirty-Three (2,693,333) shares of Series B Preferred Stock, for an aggregate of Fourteen Million Six Hundred Ninety-Three Thousand Three Hundred Thirty-Three (14,693,333) shares (the "Series B Shares") of the Series B Preferred Stock, representing Eighteen Million Three Hundred Sixty-Six Thousand Six Hundred Sixty-Seven Dollars (\$18,366,667) worth of Series B Preferred Stock. On November 21, 2002, the Issuer redeemed the Series B Shares and Chabra accepted, in exchange therefore, an aggregate of Eight Million Two Hundred Ninety-Three Thousand Three Hundred Thirty-Four (8,293,334) shares of Series C Preferred Stock, par value \$.001 per share, of the Issuer (the "Series C Preferred Stock"), representing an aggregate value of Ten Million Three Hundred Sixty-Six Thousand Six Hundred Sixty-Seven Dollars (\$10,366,667).

Payment of Expenses

The expenses listed in Part C – Question 4.a. were incurred in connection with this transaction but were not paid from the proceeds of the transaction, because there were no cash proceeds. The "proceeds" of the transaction consisted of the forgiveness and conversion of debt. The expenses listed in Part C – Question 4.a. were paid out of working capital of the Issuer.
