IntraBiotics Pharmaceuticals, Inc. ("IntraBiotics") issued 1,250,000 shares of common stock, par value \$.001 per share, to EOP-Shoreline Technology Park, L.L.C., a Delaware limited liability corporation ("EOP"), pursuant to a Common Stock Purchase Agreement by and between EOP and IntraBiotics, dated November 22, 2002 in connection with a settlement of a real estate lease termination agreement. In addition, on November 25, 2002, IntraBiotics issued 150,000 shares of common stock to a consultant for services rendered in connection with the above noted settlement.

The aggregate offering price shown in response to Item C.1, for reference purposes, represents the estimated value of IntraBiotics common stock issued in connection with the transaction based upon the closing price of \$0.29 per share of IntraBiotics stock on November 22, 2002 and the closing price of \$0.32 per share of IntraBiotics stock on November 25, 2002, each as reported on the Nasdaq National Market.
