

EXHIBIT A

Pursuant to a Plan of Reorganization and Stock Exchange Agreement (the "Agreement") by and among Little Creek, Inc., a Delaware corporation ("Little Creek" or the "Company"), Jenson Services, Inc., a Utah corporation ("Jenson Services"), The Mortgage Store Financial, Inc., a California corporation ("Mortgage Store"), and the sole stockholder of Mortgage Store, Little Creek acquired 100% of the outstanding common stock of Mortgage Store in exchange for 9,500,000 shares of "unregistered" and "restricted" common stock of Little Creek, which were valued at the net asset value of Mortgage Store at June 30, 2002, or \$1,995,000.

As a condition to the completion of the Agreement, Little Creek's Articles of Incorporation were amended to change the name of the Company to "TMSF Holdings, Inc."

Taking into account the outstanding shares of Little Creek's common stock prior to the completion of the Agreement, amounting to 1,631,483 shares, the cancellation of 1,295,118 shares of Little Creek to the treasury of Little Creek and the issuance of 9,500,000 shares to the Mortgage Store Stockholder, there are currently 9,836,365 outstanding shares of the Company.
