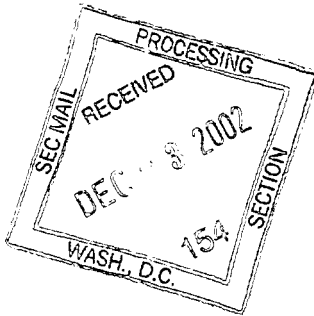

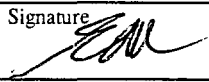

² The Partnership will pay its own organizational expenses and all legal, audit and accounting expenses, investment expenses such as commissions, research fees, interest on margin accounts and other indebtedness, borrowing charges on securities sold short, custodial fees, bank service fees, fees or expenses associated with insuring the Partnership's assets and any other reasonable expenses related to the purchase, sale or transmittal of Partnership assets as determined by the General Partner. The General Partner is responsible for the Partnership's general and administrative expenses. Such expenses include office rent, supplies, and secretarial services. The General Partner is entitled to receive an annual management fee equal to 1% of the Partnership's net asset value. The management fee is payable monthly in advance based upon the net asset value of the Partnership, as determined on the first day of each calendar quarter, and will be adjusted for any contributions made by Limited Partners during the quarter. The General Partner will also receive a performance allocation equal to 20% with respect to each Limited Partner's Net Gains for such Fiscal Year. Such expenses, management fee and performance allocation cannot be quantified at present.
