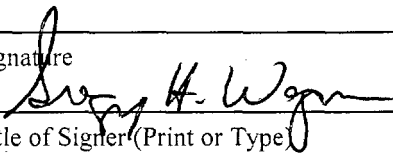

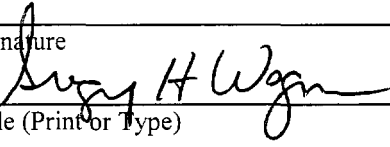

SCHEDULE A

Transaction

On August 25, 2000, the Issuer issued to each of Surinder (Sonny) Chabra ("Chabra"), Parvinder Kids Corp., a Delaware corporation ("Parvinder Kids"), Aru Kids Corp., a Delaware corporation ("Aru Kids") and Sonny Kids Corp., a Delaware corporation ("Sonny Kids" and together with Chabra, Parvinder Kids and Aru Kids, the "Investors") a senior subordinated promissory note (together, the "Subordinated Notes") in the principal amount of Four Million Seven Hundred Fifty Thousand Dollars (\$4,750,000). The aggregate principal amount of the Subordinated Notes was Nineteen Million Dollars (\$19,000,000) (the "Subordinated Debt"), plus accrued interest in the aggregate amount of Three Million Six Hundred Ninety-Four Thousand Ninety-Nine (\$3,694,099) as of the Closing Date (the "Subordinated Debt Interest" and together with the Subordinated Debt, the "Subordinated Obligation"). The Investors and the Issuer agreed to restructure the rights and obligations of the parties in order to make the Issuer more attractive for future investors and future sources of debt financings, and to increase the value of the Issuer over the long term. On November 21, 2002, the Investors converted the Subordinated Obligation into an aggregate of Thirty-Eight Million (38,000,000) shares of common stock, par value \$.001 per share, of the Issuer (the "Common Stock"). Pursuant to the Investors' instructions, the Issuer issued Nine Million Five Hundred Thousand (9,500,000) shares of Common Stock to Chabra (in his individual capacity and as the designee of Sonny Kids), Nine Million Five Hundred Thousand (9,500,000) shares of Common Stock to Narinder Chabra (as the designee of Aru Kids), and Nineteen Million (19,000,000) shares of Common Stock to Parvinder Chabra (as the designee of Parvinder Kids).

Payment of Expenses

The expenses listed in Part C – Question 4.a. were incurred in connection with this transaction but were not paid from the proceeds of the transaction, because there were no cash proceeds. The "proceeds" of the transaction consisted of the forgiveness and conversion of debt. The expenses listed in Part C – Question 4.a. were paid out of working capital of the Issuer.
