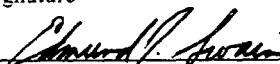

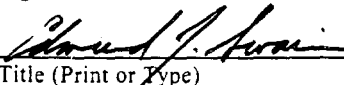

The S Main Company, LLC

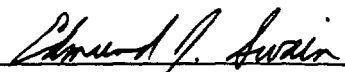
