



Footnote to Part C - Question 5

Salaries and Fees

Issuer will pay its investment manager, a quarterly advisory fee which will vary depending upon the share class and Issuer's performance relative to a predetermined "Quarterly Base Return." If Issuer's actual return is equal to or less than the Quarterly Base Return, the advisory fee for the applicable quarter is equal to (i) one quarter of 0.75% of the net asset value of Issuer for standard shares or (ii) one quarter of 0.60% of the net asset value of Issuer for committed shares. If Issuer's actual return is greater than the Quarterly Base Return, the advisory fee for the applicable quarter will be increased by (i) 15.625% of the excess, but in no event greater than a total of one quarter of 3.25% for standard shares; or (ii) 12.5% of the excess, but in no event greater than a total of one quarter of 2.6% for committed shares.
