

Exchange Of Preferred Shares

The Offering includes an offer (the "Exchange Offer") to preferred stockholders ("Preferred Stockholders") of 3553892 Canada Inc., a Canadian corporation and a subsidiary of Ensyn Group Inc., to participate in the Offering by exchanging their Preferred Stock principal payments due in 2003 and 2004 for Ensyn Share Subscriptions.

If all Preferred Shareholders accept the Exchange Offer, the net result would be that the use of funds dedicated to Preferred Shares (by exchanging Preferred Share obligations for Ensyn Shares) could total US\$ 1,128,000.
