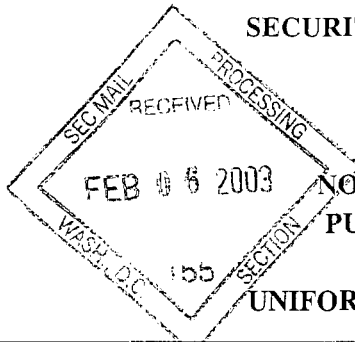

Attachment for Information About Offering

The Issuer has issued 15,106,226 shares of its newly authorized Series A Preferred Stock to its existing holders of its previous classes of preferred stock. All of such holders were accredited investors at the time of the initial issuance and are accredited investors at this time. The transaction was accomplished pursuant to a Plan of Recapitalization approved by the shareholders of the Issuer on July 9, 2002. Pursuant to the Plan of Recapitalization the Issuer's existing Series A, B, C and D Preferred Stock were combined into a new Series A Preferred Stock. In addition, a new Series B Preferred Stock was authorized and the Issuer issued 8,000,000 shares of the new Series B Preferred Stock in exchange for conversion of debt and additional cash payments. Subsequently an additional 4,855,454 shares have been issued for cash in the aggregate amount of \$2,427,727. The Series B Preferred Stock was issued to existing shareholders, affiliates of an existing shareholder of the Issuer, and one new additional investor, each of which is an accredited investor.
