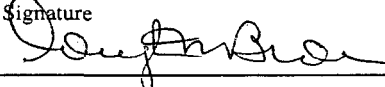

Those private Colleges and Universities ("Institutions") desiring to participate in the prepaid tuition program organized and maintained by Tuition Plan Consortium, LLC (the "Company") will, upon execution and delivery of the requisite program documents, be granted one (1) unit of membership interest in the Company. The Institutions will not be required to tender any funds to the Company in exchange for its membership interest. However, once an Institution become a member of the Company, it will be obligated to accept tuition certificates issued by the Company and tendered by a student as payment for the applicable portion of annual tuition represented by such tuition certificate. This offering relates only to the offer of membership interests in the Company to Institutions, all of which are Accredited Investors as such term is defined/used in Rule 501 of Regulation D.

B.

See A. above. There is no aggregate offering price for the membership interest in the Company as no funds will be remitted by an Institution. The aggregate offering price, should the obligation to grant educational benefits in exchange for a tuition certificate be found a security, is not currently estimable as it would be based upon a multiple of the Institutions within the State, the number of tuition certificate tendered in a given period, and the value of the educational benefits granted at the time of tender of each such tuition certificate.
