* A total of Two Million Seven Hundred Twenty Seven Two Hundred Seventy Three (2,727,273) Units are being sold in this amended offering. Each Unit consists of one share of common stock and one common stock purchase warrant exercisable at 75% of the 21 day average bid and ask price on the OTCBB for an exercise period of two years. This could potentially bring in another \$1-3 million dollars, depending upon the average stock price, all of which will be applied toward working capital and general and administrative expenses.

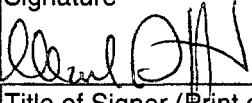
