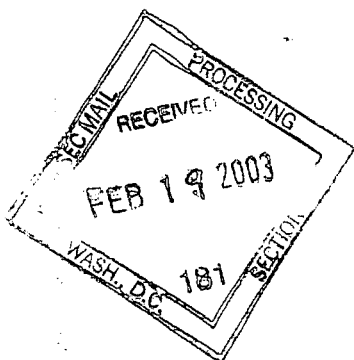

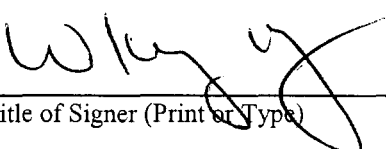

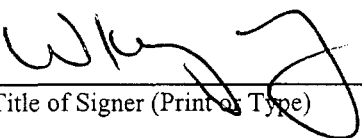

Exhibit "A"

Hydro Dynamics, Inc. (the "Company"), has entered into a Line of Credit Agreement and Unsecured Convertible Promissory Note (the "Note") with W. Kelly Hudson, Jr., its President and Chief Executive Officer. Pursuant to the Note, the Company may borrow up to \$500,000 from Mr. Hudson from time to time at an annual interest rate equal to the "prime" rate charged by Georgia Bank & Trust Company, plus 1.0%. The Note provides that a certain amount of the unpaid principal amount and accrued interest under the Note may automatically convert into shares of the Company's Series B Preferred Stock, depending on the amount of proceeds that it receives from its offering of Series B Preferred Stock. Mr. Hudson may convert amounts due under the Note into shares of Series B Preferred Stock at any time.

The Company will repay all amounts that it has borrowed under the Note, plus accrued interest, on the earlier of December 31, 2003, and such time as such amounts are declared due and payable following an event of default. The Company will also repay \$250,000 of the outstanding principal amount, plus accrued interest, at such time as the amount of proceeds that the Company has received from this offering, when added to the \$500,000 that may be borrowed under the Note, equals or exceeds \$1.75 million. The Company will repay the remaining unpaid principal amount, plus accrued interest, at such time as the amount of proceeds that it has received from this offering, when added to the \$500,000 that may be borrowed under the Note, equals or exceeds \$3.0 million.

If, on the earlier of the closing of this offering and December 31, 2003, the amount of proceeds that the Company has received from this offering, when added to the \$500,000 that may be borrowed under the Note:

- equals or exceeds \$1.0 million, but is less than \$1.75 million, then \$500,000 will automatically convert into shares of Series B Preferred Stock, regardless of how much the Company has actually borrowed under the Note;
- equals or exceeds \$1.75 million, but is less than \$3.0 million, then \$250,000 will automatically convert into shares of Series B Preferred Stock, regardless of how much the Company has actually borrowed under the Note;
- equals or exceeds \$3.0 million, then none of the outstanding principal amount and accrued interest under the Note will convert into shares of Series B Preferred Stock; provided, however, that in such event, Mr. Hudson has agreed to purchase a minimum of \$50,000 of Series B Preferred Stock.

In the event there is an event of default under the Note, or if the Company's Board of Directors terminates this offering prior to receiving proceeds from this offering that, when added to the \$500,000 that may be borrowed under the Note, do not exceed \$3.0 million, then the mandatory conversion provisions of the Note will not apply.
