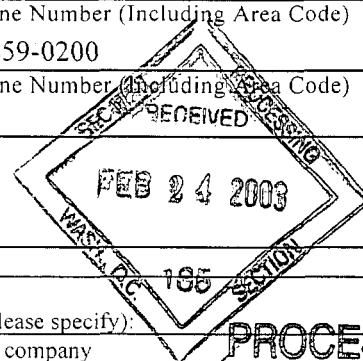

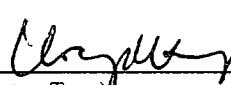

The Fund will also pay the Advisor an Incentive Fee equal to 20% of New Appreciation in each Non-Manager Member's Capital Account, based on profits generated above the High Water Mark of the Member's Capital Account over a specified period.

All capitalized terms used in this Form D but not defined have the meanings ascribed to them in the Confidential Private Placement Memorandum of the Fund dated April 30, 2002.
