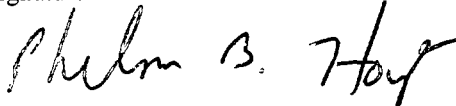

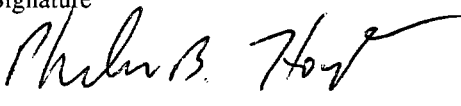

This Form D concerns the issuance of up to 33,924 units of Common interests and up to 967 units of Series B Junior Preferred interests in KDP, LLC ("KDP") in connection with the organization of KDP. Pursuant to Exchange Agreements between KDP and shareholders of KDP Investment Advisors, Inc. ("KDPIA") and shareholders of KDP Asset Management, Inc. ("KDPAM"), each such shareholder shall receive units of Common and/or Junior Preferred interests in KDP. The number of such Common and/or Junior Preferred units to be received by each such shareholder and such shareholder's percentage interest in KDP following the exchange (assuming that each shareholder of KDPIA and KDPAM exchanges such shareholder's shares for interests in KDP) are set forth in the Exchange Agreement between KDP and such shareholder.
