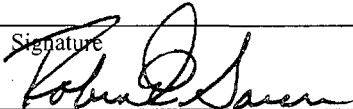

ATTACHMENT 1

The Company offered and sold 24 of its Class A Non-Voting Membership Units (“Units”) in exchange for (i) a nominal purchase price of \$1.00 per Unit and (ii) delivery of an irrevocable direct pay transferable letter of credit in the amount of \$350,000 per Unit issued by a third party financial institution in favor of U.S. Bank National Association (the “Bank”), for the purpose of securing a portion of two credit facilities established by the Bank in favor of the Company.

The only cash proceeds of the Offering were the nominal subscription payments received by the investors. All letters of credit submitted by investors were delivered to the Bank, as described above.
