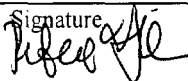

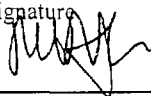

ANNEX C.1

This Form D relates to the sale and issuance of Series A Preferred Stock of ACCDX, Inc. (the "Preferred Stock") and issuance of Common Stock upon conversion of the Preferred Stock. The amount reported under "Convertible Securities" is the purchase price of the Preferred Stock. Of the securities offered, \$1,000,000 represent sale of the Preferred Stock sold at the first closing and \$200,000 represent sale of the Preferred Stock sold at the second closing. It is contemplated that \$815,150 of Preferred Stock will be sold to the same purchasers when certain milestones have been achieved by the Issuer. The "Adjusted Gross Proceeds" in Section C.4.b. and "Total Payments" in Section C.5. reflect the sale of Preferred Stock at the first and second closings.
