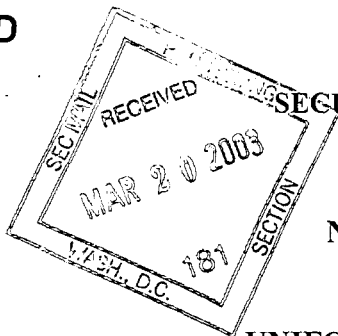

¹ The Company plans to offer its Series B-2 Preferred Stock (the "Series B-2 Stock") as part of a two-stage investment; Stage 1 will involve the sale of up to \$3 million of Secured Convertible Promissory Notes (the "Notes"), which automatically convert into shares of Series B-2 Stock upon the sale of an aggregate of \$3,000,000 of Notes. Stage 2 involves the subsequent sale of shares of Series B-2 Stock. In connection with the sale of the Notes, and later the Series B-2 Preferred Stock, investors will receive warrants to purchase a number of shares of Series B-2 Stock ranging from 100 – 150% of the amount invested in the financing.

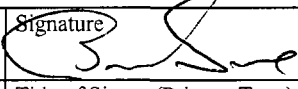
