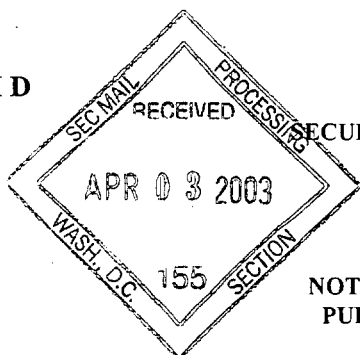

The Robinson #7-X Well will be drilled to a depth of 3,000 feet, or a depth sufficient to test the Altered Cretaceous formation.

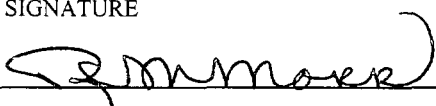

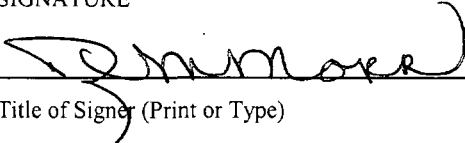
