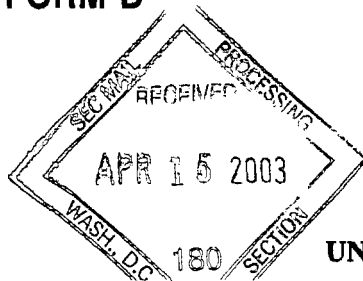

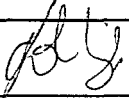

- * The general partner and its assignees receive a quarterly cash fee in an amount equal to 0.25% of partner account balances and an annual incentive profit allocation generally equal to 20% of realized and unrealized limited partner capital account appreciation. The Issuer will also reimburse the general partner and its affiliates for approximately \$9,250 of organizational and initial offering expenses.
