



- ⁽²⁾ This is an estimated aggregate offering price. This is a continuous offering. The minimum aggregate offering price is \$250,000.
- ⁽³⁾ The amounts stated are the estimated expenses of the Fund over the course of the offering. The amounts stated assume a three-year offering during which the Fund pays estimated annual expenses of \$5,000, \$15,000, and \$10,000 for printing fees, legal fees, and accounting fees, respectively. The Fund will also pay commissions of 2% to 6% per sale to its selling agents, and per-transaction commissions to its commodity broker.
- ⁽⁴⁾ The Fund will pay the Manager a monthly Client Servicing Fee equal to 0.83% of the Closing Capital Account Balance of each Non-Manager Member.
- ⁽⁵⁾ The Fund will pay Mangin Capital Management, Inc. (the "Advisor") a monthly Management Fee equal to 1/2 of 1% of the Closing Capital Account Balance of each Non-Manager Member at the end of the month. The Fund will also pay the Advisor an Incentive Fee equal to 20% of New Appreciation in each Non-Manager Member's Capital Account, based on profits generated above the High Water Mark of the Member's Capital Account over a specified period.

All capitalized terms used in this Form D but not defined have the meanings ascribed to them in the Confidential Private Placement Memorandum of the Fund dated April 30, 2002.


