

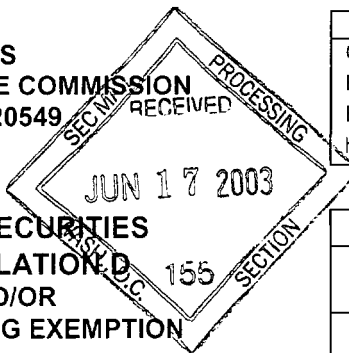



EXHIBIT A

The General Partner will be entitled to receive a performance allocation at the end of each calendar quarter equal to 10% of the portion of the Partnership's net income (including net unrealized gains and losses and net of the Management Fee) attributable to each Limited Partner as of the close of such quarter. This amount will be allocated to the General Partner's capital account and debited from each Limited Partner's capital account. This allocation (the "General Partner's performance allocation") will be in addition to any allocations of income and profits, or losses, that the General Partner might be entitled to receive based upon any capital contributions it may make. The General Partner's performance allocation is charged to each Limited Partner's capital account separately, based on the amount and fluctuations of the capital account. The General Partner shall also receive the performance allocation upon any withdrawal of funds by a Limited Partner, whether voluntary or involuntary, and upon termination of the Partnership. The General Partner may, in its sole and absolute discretion, waive its performance allocation attributable to any Limited Partner's capital account, in part or in its entirety, for any reason or for no reason at all. The General Partner may agree with a Limited Partner to apply a different performance allocation for such Limited Partner.

The General Partner's performance allocation is subject to what is commonly known as a "high water mark" procedure. That is, if the Partnership has a loss in any fiscal quarter, this loss will be carried over as to each Limited Partner to future fiscal quarters (such amount is referred to as the "Loss Carryover"). Whenever there is a Loss Carryover, the General Partner will not receive a performance allocation from a Limited Partner until the Loss Carryover for such Limited Partner is exceeded by the cumulative profits for the fiscal quarter following the Loss Carryover. Thereafter, the General Partner's performance allocation will be equal to the applicable percentage of the excess cumulative profits as to each Limited Partner, rather than on all profits. The "high water mark" procedure prevents the General Partner from receiving a performance allocation as to profits that simply restore previous losses and is intended to ensure that each performance allocation is based on the long-term performance of an investment in the Partnership. The Loss Carryover, like the performance allocation, is calculated separately for each Limited Partner. If a Limited Partner withdraws funds from its capital account at a time when it has a Loss Carryover, the amount of the Loss Carryover applicable to that Limited Partner's capital account will be reduced pro rata in proportion to the amount of the capital account withdrawn.

In consideration for its services, the General Partner will receive a management fee, payable quarterly and in advance, equal to 0.25% (approximately 1% annually) of each Limited Partner's share of the Partnership's net worth (determined as of the beginning of each fiscal quarter of each year). A pro rata management fee will be charged to Limited Partners on any amounts permitted to be invested during any fiscal quarter. No part of the management fee will be refunded in the event that a Limited Partner withdraws all or any part of its capital account during a fiscal quarter. The General Partner may, in its sole and absolute discretion, waive the management fee charged to any Limited Partner, in part or in its entirety, for any reason or for no reason at all. In certain cases, the General Partner and an investor may agree to apply a different management fee for that investor.

EXPENSES:

The Partnership will incur its own expenses. The Partnership shall pay or reimburse the General Partner for all costs and expenses incurred by or on behalf of the Partnership, or for its benefit, including (A) all expenses incurred in connection with the offer and sale of Interests, including but not limited to marketing expenses, printing of the Partnership's Memorandum and exhibits thereto, documentation of performance, attendance at industry related events and the admission of Limited Partners; (B) all operating and administrative expenses of the Partnership such as tax preparation fees, governmental fees and taxes, insurance, administrator fees, communications with Limited Partners, and ongoing legal, accounting, auditing, bookkeeping, consulting and other professional fees and expenses; (C) all Partnership trading and investment related costs and expenses (e.g. brokerage commissions, margin interest, expenses related to short sales, custodial fees and clearing and settlement charges); (D) all expenses incurred in connection with investigating, researching, selecting and monitoring investment managers; and (E) all fees to protect or preserve any investment held by the Partnership, as determined in good faith by the General Partner, and fees and other expenses incurred in connection with the investigation, prosecution or defense of any claims by or against the Partnership.

The Partnership shall pay or reimburse the General Partner for all expenses related to organizing the Partnership, including but not limited to, legal and accounting fees, printing and mailing expenses and government filing fees (including blue sky filing fees). The Partnership intends to amortize organizational expenses over a period of sixty (60) months from the date the Partnership commences operations because it believes such treatment is more equitable than expensing the entire amount of the Partnership's organizational expenses in the Partnership's first year of operation, as required by U.S. generally accepted accounting principles.
