#### LISTING AGREEMENT: CHANGE IN DIRECTORS

In terms of Clause 30A of the Listing Agreement, we advise that the Central Government in pursuance of clause (ca) of Section 19 read with sub-section (3A) of Section 20 of the State Bank of India Act, 1955 (23 of 1955), and in exercise of the powers vested under Rule 3 of the State Bank of India (Appointment of Employee Directors) Rules, 1974, appointed Shri Ananta Chandra Kalita, Head Assistant, State Bank of India as a Director on the Central Board of the Bank from amongst the employees of State Bank of India, who are workmen, for a period of three years commencing from 15th July, 2003 or until he ceases to be a workman employee of the Bank or until further orders, whichever is earlier provided that he shall not hold the office continuously for a period exceeding six years.
